# Planning documents on public exhibition

## Project overview

The NSW Government is investing \$200 million in the Bathurst Hospital Redevelopment to provide patients, staff and carers with access to modern facilities and expanded healthcare services to meet the healthcare needs of the Central West region now and into the future.

The redevelopment will include an expanded emergency department and maternity services alongside a new modern non-acute mental health inpatient unit (Panorama Clinic). It is also expected to include improvements to inpatient, outpatient and community health services, operating theatres, cardiology services and a new paediatrics zone.

## Public Exhibition Consultation

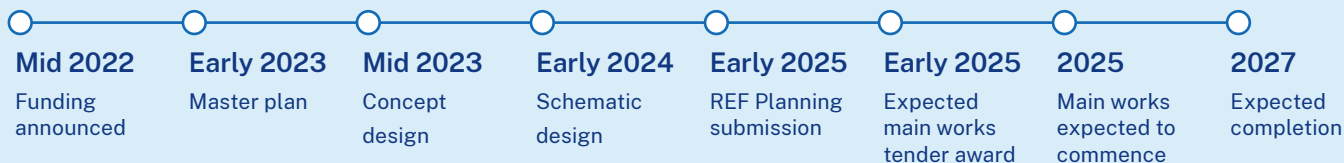

Due to the legislative change that was announced by the NSW Government on 22 November 2024, the Bathurst Hospital Redevelopment will be assessed as a Review of Environmental Factors (REF) instead of lodged as a State Significant Development Application (SSDA).

## Car parking

More than 70 additional car parking spaces are planned to be delivered onsite and in the surrounding streets to support the redevelopment. This includes 46 additional parking spaces at key locations on the campus providing a significant boost to the existing 306 car spaces for staff, patients and visitors.

Access to the hospital for patients, staff and visitors through pedestrian access, car parking and public transport will be delivered through the new Mitre Street front entrance, retention of the Howick Street entrance.

## Managing construction impacts

Construction of the Bathurst Hospital will commence in 2025 pending planning approval. Bathurst Hospital will remain open and continue to provide services during construction. A well-planned and staged construction approach will minimise any interruptions and impacts to hospital services.

There will be changes to access arrangements at the site. Any changes will be communicated with staff, patients, visitors and the community well in advance. Patient, visitor, staff and emergency access will always be maintained. The building contractor is

required to minimise the effects of dust, noise and disruption to existing services. This includes taking reasonable preventative measures to impacts on adjoining properties.

We recognise that construction work has the potential to affect our neighbours and the local community. We will continue to consult with the community as the project progresses to reduce the impact of construction on our neighbours.

## Arts and culture



The Arts in Health Program integrates arts into NSW Health capital works to create engaging public health spaces and improve clinical health and wellbeing outcomes for patients, staff, and visitors.

We will collaborate closely with artists, patients, staff and carers, architects, and designers through planning, delivery, and commissioning stages to ensure the experience reflects the unique qualities of the Bathurst region, its people, and values.

## Next steps

Construction is expected to start in 2025 following planning approvals.
